DECISION 8- In accordance with Article 28/b-3 of the Undergraduate Education and Examination Regulation of our University and Article 15/3-ç of the Graduate Education and Examination Regulation, *"I: Incomplete. It is a grade given temporarily to students who are successful in the semester but cannot complete the necessary requirements for the course due to illness or another valid reason. If the student completes the deficiencies within two weeks from the date of delivery of the grades, it turns into a success grade, if not, it turns into F, and if it is a non-credit course, it turns into U."* In order to meet the grade entry process of the I grade and the graduation demands of the students in a short time, it was decided unanimously by the participants of the meeting that the conversion of the I grade into a letter grade and the follow-up of the process is the responsibility of the Dean / Director, Department / Department Heads, Common Courses and Foreign Languages Coordinatorships.
