**DECISION 1-** Based on the letter from the Directorate of the Alliance of Civilizations Institute dated June 27, 2024, with reference number 42751, the second application period calendar for Turkish students for the 2024-2025 academic year was unanimously approved by the attendees as detailed in the table below:

REGULATION OF THE GUIDANCE AND PSYCHOLOGICAL COUNSELING APPLICATION AND RESEARCH CENTER		
Old Article (Article 8)	New Article (Article 8)	
ARTICLE $8 - (1)$ The Director shall be appointed by the Rector for a term of three years from among the faculty members of the guidance and psychological counseling department related to the Center's field of work. The Director may be removed by the Rector. The Director whose term has expired may be reappointed. The Director is accountable to the Rector for the Center's activities.	ARTICLE 8 – (1) The Director shall be appointed by the Rector for a term of three years from among the University faculty members related to the Center's field of work. The Director may be dismissed by the Rector. The Director whose term has expired may be reappointed. The Director is accountable to the Rector for the Center's activities.
