# **MEETING QUORUM**

The Senate meeting was held under the chairmanship of Rector Prof. Dr. Atilla Arkan. Out of the 18 Senate members, 12 attended the meeting. A quorum was established, and the agenda items listed below were discussed.

## **AGENDA**

- 1. Based on the letter dated 02.08.2024 with the reference number 44432 from our Graduate School of Education;
- a) Determination of student quotas separately for Turkish citizens and international students for admission and transfers to the master's and doctoral programs for the 2024–2025 academic year.
- b) Review of the English language proficiency requirements for admission and transfer applications to the Radio, Television, and Cinema Master's Program with Thesis.
- c) Consideration of the second application period for the Thesis Master's Program in Fundamental Islamic Sciences for the fall semester of the 2024–2025 academic year, including the application and evaluation criteria, quota numbers, and evaluation weights.
- d) Discussion on the language score criteria accepted for the Thesis and Non-Thesis Master's programs in Air Transportation Management.
- e) Examination of the request to add a new language under the Multilingualism scope to the Psychology Doctoral and Economics Master's and Doctoral programs.

### **DECISIONS**

**DECISION 1-** In response to the letter dated 02.08.2024 with reference number 44432 from our Graduate School of Education:

- a) For the 2024–2025 academic year, the student quotas for admission and transfers to master's and doctoral programs are to be set separately for Turkish citizens and international students as detailed in Appendix-1. If the quotas are not filled, transfers may be made between the quotas assigned to Turkish citizens and international students, provided that the total quota for the program is not exceeded. (Appendix-1)
- b) Since the language of instruction for the Radio, Television, and Cinema Master's Program with Thesis is Turkish, English language proficiency will not be required. The admission and transfer application requirements table is accepted as specified in Appendix-2. (**Appendix-2**)
- c) A second application period will be opened for the Thesis Master's Program in Fundamental Islamic Sciences for the fall semester of the 2024–2025 academic year. Applications will be

- accepted with the previously determined application and evaluation criteria, quota numbers, and evaluation weights remaining the same.
- d) For the Thesis and Non-Thesis Master's Programs in Air Transportation Management, the THY Academy English exam score will be considered equivalent to the YDS and will be accepted with a minimum score of 65 for applications in the 2024–2025 academic year.
- e) The following courses will be added to the list of third language proficiency requirements under the Multilingualism Principles by the Heads of Departments:
