**RESOLUTION 1-** Pursuant to Article 19, Paragraph 5 of our University's Undergraduate Education and

Examination Regulation, it has been decided that the maximum total credit load students can take in a

semester, including courses from double major and/or minor programs, shall be 42 ECTS.

**RESOLUTION 2-** Based on Article 6, Clause (b) of the Council of Higher Education's Regulations on

Distance Education in Higher Education Institutions and considering that the primary mode of

instruction is face-to-face education, it was unanimously decided by the attendees to open the courses

specified in Annex-1 for the Fall semester of the 2024-2025 academic year for our University's

Preparatory, Undergraduate, and Graduate programs. It was also decided that educational activities may

be conducted up to a maximum of 30% through distance education and that all examinations will be

conducted face-to-face. This decision will be submitted to the Council of Higher Education for
