1. Discussion of the request to annul the decision regarding Z\*\* O\*\*\*'s course addition request, based on the official letter dated 23.03.2025 and numbered 52469 from the Dean's Office of the Faculty of Law of our University.
2. Discussion of the reconsideration of the effective term for the implementation of the criteria for receiving Honour and High Honour Certificates for undergraduate students of our University, as determined by the Senate Decision dated 12.05.2023 and numbered 2023/09.

## **RESOLUTIONS**

**RESOLUTION 1-** The Senate Decision dated 21.03.2025, numbered 2025/04 and item no. 04, was reconsidered. Following the discussions, based on the official letter dated 23.03.2025 and numbered 52469 from the Dean's Office of the Faculty of Law, and in view of the fact that the student of the Faculty of Law, Z\*\* O\*\*\* (student ID: 200244012), did not exceed the 42 ECTS credit limit, it was unanimously resolved by the attendees of the meeting to annul Senate Decision dated 21.03.2025, numbered 2025/04 and item no. 04.

**RESOLUTION 2-** Pursuant to the petition dated 24.04.2025 and numbered 56498 from the Ö\*\*\*\* T\*\*\*\*\* K\*\*\*\*\* T\*\*\*\*\* A\*\*\*\*\* M\*\*\*\*\* of our University, it was unanimously resolved by the attendees of the meeting to accept the proposal to revise the implementation period of the criteria for awarding Honour and High Honour Certificates, as stated in the Senate Decision dated 12.05.2023, numbered 2023/09, item no. 04, such that undergraduate students who enrolled before the 2023–2024 academic year shall be exempt from the revised criteria, and that the criteria shall be implemented for students enrolled as of the 2023–2024 academic year.
