RESOLUTION 5- Pursuant to the letters of the Dean's Office of the Faculty of Law dated 03.07.2025 and numbered 59724 and 59725, the proposals regarding the enrollment of the students of the Faculty of Law, İ***** Y***** (ID: 21*****4) at A***** B***** U***** and A***** D***** (ID: 21*****2) at F***** S***** M***** V***** U***** for summer school courses were discussed. As a result of the deliberations, and in accordance with the provision in the Higher Education Executive Board meeting dated 25/06/2014 that *"pursuant to Article 7/c of Law No. 2547, as amended by Law No. 2880, it is decided that universities where summer school is not offered shall determine through their senates at which other higher education institutions students may take summer school courses, and in cases where higher education institutions where summer school can be taken are not determined, if a student takes courses at a university where a program is offered with a higher base score than the university's program in the relevant year, these courses shall be accepted by the university"*, it has been decided unanimously by the attendees of the meeting to reject the requests of the aforementioned students to take courses at the specified universities due to the lower base score of these universities in the relevant year.

RESOLUTION 8- It has been decided unanimously by the attendees of the meeting that the tuition fees and cash scholarship amounts for currently enrolled undergraduate students at our University for the 2025–2026 Academic Year shall be approved as specified below and submitted to the Board of Trustees:

- The tuition fees for students admitted through YKS shall be increased by applying a 1% reduction on the annual CPI rate calculated for May 2025;*
- No increase shall be applied for international students enrolled in undergraduate programs;

*** The cash scholarship amount for students who have a dormitory scholarship but do not reside in the dormitory will be finalized and announced after the Youth and Sports Ministry determines the KYK Meal and Accommodation Scholarship.
