RESOLUTION 3- In accordance with the letter dated July 23, 2025, numbered 60629, from the Directorate of the Graduate School of our university, it was decided by unanimous vote of those present at the meeting to accept the application criteria for the 2025-2026 academic year fall semester for master's program entrance and lateral transfer applications, as well as the evaluation criteria and weights to be applied by the evaluation committee, as specified in Annex 2. RESOLUTION 4- Pursuant to the letter dated July 31, 2025, numbered 61024, from the Directorate of the Institute of the Alliance of Civilizations at our university, The application files prepared for the Thesis-Based Master's Program, which was deemed appropriate for opening by the decision of the Institute Council of the Alliance of Civilizations Institute dated July 30, 2025, numbered 2025/04, and whose details are provided below, were reviewed. As a result of the discussions, it was unanimously decided by those attending the meeting that the application file, as presented in Annex 3, should be accepted in accordance with Article 7/d-2 of Higher Education Law No. 2547 and the Higher Education Institutions Organization Law No. 2809, and submitted to the Presidency of the Higher Education Council. RESOLUTION 5- The exemption conditions for Arabic courses with codes ARA 301, ARA 302, ARA 303, and ARA 304, taken within the scope of multilingualism in our university's undergraduate programs, were determined as follows, and the decision was made unanimously by those attending the meeting.

- Obtaining a minimum score of 60 on the Arabic Exemption Exam of the School of Languages,
- A certificate showing a score of at least 50 points obtained in the YDS and YÖKDİL exams within the last five years,
- Proof of successful completion of an Arabic Preparatory Program at another university in Türkiye within the last five years,

- Submission of a secondary education level graduation certificate from a country where Arabic is the native language,
- Submission of a certificate of at least intermediate-mid level from an official level assessment exam conducted by the Qasid Institute or ACTFL.
- Fulfillment of other exams or conditions deemed appropriate by the Senate.
 - * Fulfillment of one of the conditions specified for exemption is sufficient.

RESOLUTION 6- Pursuant to the letter dated 24.07.2025 and numbered 60666 from our University's Faculty of Law, the decision made at the meeting of the Higher Education Executive Board on 25/06/2014 states: "In accordance with Article 7/c of Law No. 2547, as amended by Law No. 2880, it was decided that for higher education institutions that do not offer summer courses, the university senates shall determine which other higher education institutions students may take summer courses at. If the higher education institutions where summer courses may be taken are not determined, and if the student takes summer courses at a university offering a program with a higher minimum score than the university's program in the relevant year, the courses taken shall be accepted by the university. In accordance with the provision of, it was unanimously decided by those attending the meeting to accept the proposal for students of our University's Faculty of Law to take courses at the summer school from the other higher education institutions listed in the table below.
