RESOLUTION 1- Pursuant to the letter dated August 5, 2025, numbered E-75850160-199-39354, and titled “2025-2029 Judicial Reform Strategy Document” from the Presidency of the Higher Education Council (Department of Education and Training), In line with the Ministry of Justice's objectives to enhance the quality of legal education within the scope of the 2025-2029 Judicial Reform Strategy Document, and specifically the activity item titled “Assessment and Evaluation in Law Faculties” under activity item 2.1.e, which states: “Efforts will be made to prioritize the use of written exams over test techniques as a measurement and evaluation tool in law schools.” and the relevant legislation, it was unanimously decided by those attending the meeting to give greater weight to written examination practices in the measurement and evaluation systems at our University's Faculty of Law.
